ACADEMIC RULES & REGULATIONS FIVE YEAR INTEGRATED M. TECH. DEGREE PROGRAM

Preamble

- 1. The integrated M. Tech. degree program is a five year programme derived by full integration of B. Tech. and M. Tech. programmes in the respective discipline.
 - (i) Int. M. Tech. in ECE is integration of B. Tech. ECE and M. Tech. ECE with specialization in Communication Systems.
 - (ii) Int. M. Tech. in CSE is integration of B. Tech. CSE and M. Tech. CSE
 - (iii) Int. M. Tech. in Biotechnology is integration of B. Tech. Biotechnology and M. Tech. Biotechnology

Admission / Eligibility

- 2. The students shall be admitted directly into the Program, as per admission policy laid down from time to time by the Management. The procedure of admission shall generally remain the same, as for regular B. Tech students i.e based on their all India Rank in Joint Entrance Examination (JEE) conducted by CBSE.
- 3. <u>Lateral Admission</u> The procedure of admission shall generally remain the same, as for regular lateral entry for B. Tech students.

Conduct of Program

- 4. <u>Rules Till completion of B Tech Degree requirements</u> The students admitted to the Programs shall be governed by the Rules & Regulations, laid down in the Academic System for B. Tech Program, as modified from time to time, up to 6th semester.
- 5. <u>Rules for the M Tech Degree requirements</u> The students shall be Governed by the rules and regulations off M Tech program during the last (10th and 11th) two semesters dealing specifically with M Tech courses.
- 6. During 7th, 8th and additional summer semester (9th Sem) students will be governed by rules and regulations of B. Tech. programme for B. Tech. level subjects and by rules and regulations of M. Tech. programme for M. Tech. level subjects.

7. Course Structure

The curricula of the integrated M. Tech. degree program is full integration of B. Tech. and M. Tech. Programs and is same as B. Tech. program up to 6th semester and there after it is a mix of B. Tech. and M. Tech. programs in accelerated mode so as to complete all requirements within five year time.

8. Evaluation and Grading System

The evaluation shall be carried out as per existing policy. The structure of grading of performance shall continue to be as per the Academic System governing the B. Tech. / M. Tech program as per the level of the subject.

9. Project / Thesis / Dissertation / Industrial Project / Seminar and Term Paper
The general instructions for submission and evaluation of these courses at B. Tech
and/or M. Tech levels, as the case may be, shall be same as per instructions and
procedure laid down for respective programs.

- **10.** <u>Conditions for Award of Degree</u> For a student to qualify for award of integrated M. Tech. degree, following conditions are mandatory: -
 - (a) Obtaining a CGPA of 4.5 and above in the program.
 - (b) Earning a minimum of (i) 263 Credits for batches admitted in academic year 2017-18 or earlier, (ii) 228 Credits for batches admitted in academic year 2018-19 or later / Minimum Credits as laid down in the applicable program structure.
 - (c) All core, qualifying and mandatory courses must be cleared, as defined in the Integrated Degree curricula.
 - (d) Completing the requirements of the Program in a maximum of seven years.
 - (e) Completion of requirement of Industrial Training as essential for B. Tech Program.
- **11.** <u>Conditions for Progression and Termination of Registration</u> A student shall be de-registered if he / she fails to meet the following criteria for continuation of the Program: -
 - (a) Fails to meet the requirements for progression as laid down in the Academic System for the respective phase's i.e. B Tech and M Tech.
 - (b) The progress beyond six years shall be allowed only on approval of the Vice Chancellor.
 - (c) No Degree shall be awarded in case a student fails to complete the requirements of the Integrated Degree Program in maximum of seven years.

12. <u>Teaching Assistantship</u>

The Teaching Assistantship in the 5th Year shall be governed by the existing Rules for M. Tech students, subject to limitation on numbers selected for the award, which shall be as decided by the management.
